### HOW TO USE

Spraying and / or rubbing of surfaces, immersion of utensils or circulation in machines, pipes or tanks. Apply in the absence of food.

Dosage: dilute the product in water at 2.5-6%, depending on the type, amount of dirt and method of application required. Leave the product solutions in contact with the surfaces for at least 10 minutes. Rinse treated surfaces and utensils with water before use. Empty containers must be managed according to their dangerous characteristics and in accordance with the regulations in force through authorized waste managers.
